All successful Applicants will receive additional rules and conditions for the Grant in a subsequent series of disclosures before the funding will commence. Regina Mundi reserves the right to modify, withdraw, or terminate any Application process, any Grant, and any conditions imposed as a part of the Grant application and award process.
